The above vacancies are now in existence. - 4 Method of appointment : Direct Recruitment  
5 Age Limit : Age 20-35 ie, Only candidates born between 2.1.1976 and 01.01.1991 (both dates included)are eligible to apply for this post. Other Backward communities and SC/ST candidates are eligible for usual age relaxation.

6. Qualifications:

- a) A Post Graduate Degree in Ayurveda in the concerned, subject from any of the

Universities in Kerala or from any other University recognised by any of the Universities in Kerala.

- b) Permanent 'A Class' Registration with Travancore Cochin Medical Council [Council of Indigenous Medicine]

Note:-	(i)	If Post graduate qualification holders in concerned subjects are not available, the candidates with Post Graduate degree in Kayachikitsa or Basic Principles for Swastha Vritha and the candidates with Post Graduate Degree in Kayachikitsa or Dravyaguna for Agadathanthra shall be admissible.
	(ii)	In the absence of persons with Post Graduate Degree in the concerned subject, person with Graduation will be considered.

**Probation:-** Every person appointed to this post shall from the date on which he joins duty be on probation for a total period of two years on duty with in a continuous period of three years.

7. Mode of submitting Applications :

Applications with photograph uploaded shall be submitted online only. Detailed instructions regarding the submission of applications are available in the website of Kerala Public Service Commission viz. [www.keralapsc.org](http://www.keralapsc.org). No application fee is required. The barcode number in the application form shall be quoted in all further enquiries/correspondences. Documents to prove qualification and Service Certificate in original have to be produced as and when called for. Applications which are not submitted in accordance with the instructions given in the website will be summarily rejected.

At the time of Examination, Physical Efficiency Test, Practical Test, Interview etc Candidates shall produce their Photo affixed ID proof in Original and self attested photocopy of any one of the following documents (Voters Identity Card, Driving Licence, Passport, Identity Cards issued by Social Welfare Department to Physically Handicapped Candidates, Photo affixed Pass Books issued by Nationalized Banks, PAN Card, Identity Cards issued to Government Employees by the concerned Departments) along with Hall Tickets.
