- 2 Name of post : Assistant Engineer (Electrical)  
(Special Recruitment from Scheduled Tribe only)
- 3 Scale of pay : ₹ 13215-20655/-
- 4 No. of vacancies : 22 (Twenty two)

**Note:-** The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of Three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from ST only during the pendency of the list.

- 5 Method of Appointment : Direct Recruitment (Special Recruitment from Scheduled Tribes only).

**Note:-** Applications received from candidates other than Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

- 6 Age Limit : 18 – 40.years. Only candidates born between 02.01.1971 and 01.01.1993 (both dates included) are eligible to apply for this post. (No other age relaxation will be allowed)

**Note:-** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications :

1. Degree in Electrical Engineering from a recognized University or its equivalent

OR

2. Degree in Electronics & Communication Engineering of any recognized University or its equivalent.

OR

3. AMIE (India) part A and B in Electrical Engineering.

OR

4. Associate Membership Diploma in Electrical Engineering of Institute of Engineers (India) or any other Diploma recognised as its equivalent there to.

**Probation** Every person appointed to this post shall be on probation from the date on which he joins duty for a period of two years on duty within a continuous period of three years.
