- i. Conventional type applications will be summarily rejected. Candidates shall apply only through online application available at the Kerala Public Service Commission website www.keralapsc.org.
 - ii. Applications submitted by candidates belonging to the communities other than those notified will be summarily rejected. No rejection memo will be issued.
 - iii. Separate Ranked list will be prepared for each district in pursuance of this notification. Ranked List thus prepared and published as per this notification shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post in the following district.

- iv. Reservation community candidates shall submit application for the post to the concerned district officers where the vacancy is existing for their respective communities and note the name of that district against the relevant column of the online application. Applications shall not be sent to more than one district in pursuance of this notification. If applications are submitted contrary to the above direction and if he/she selected, his/her name will be removed from the Ranked list and disciplinary action will be taken against him/her.

- v. The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in GO(Ms) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one revenue district from the Ranked List prepared is not eligible for transfer to another district. Even if transfer is allowed after five years, it will be subject to the rules in GO(MS) No.4/61/PD dated, 2.1.1961. Candidates already in Government service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

5. Method of appointment : Direct Recruitment (from candidates belonging to Latin Catholic/Anglo Indian, Dheevara communities only)
6. Age : 18-42. Only candidates born between 02.01.1969 and 01.01.1993 (both dates included) are eligible to apply for this post in the case of LC/AI and Dheevara [Including the relaxation as per para 2 (1) of General Condition]

Note:- For conditions regarding other age relaxation please see para 2 of the General Conditions. Except para 2 (i)

7. Qualifications:

- 1) A pass in SSLC Examination conducted by the Commissioner for Govt. Examinations, Kerala or its equivalent.

OR

A pass in Pre-degree examination conducted by any of the Universities in Kerala or any examinations recognized by any such Universities in Kerala as equivalent to Pre-degree examination

OR

A pass in Higher Secondary Examination conducted by the Board of Higher Secondary Examinations, Kerala or any other examinations, recognized by Government as equivalent thereto

And

- 2) A pass in TTC Examination conducted by the Commissioner for Govt. Examinations, Kerala.

Special Note: -

- i) B.Ed certificate will not be considered in lieu of TTC
- ii) Candidates who have not studied the Regional language 'Malayalam' either under Part I or Part II or as Medium of Instruction of SSLC, will not be eligible for appointment to the post. (GO(Rt) No. 534/02/G.Edn dated 19.03.02, G.O (MS) N0. 44/75/G.Edn dated 29.1.1975).
- iii) Question paper for the written test, if any, will be in Malayalam. The candidates should answer the questions in Malayalam.

8. SPECIAL CONCESSIONS REGARDING APPOINTMENT AND AGE LIMIT

- i) Preference will be given as laid down in G.O.(MS) No.50/70/PD dated 12.2.70 and G.O. (MS)No.9/78/G.Edn.dated 21.1.78 to the wives of Jawans in the matter of recruitment as Teachers, if they possess the prescribed qualifications. Soldiers in active service and those working in Base establishment are included under the terms of Jawans. Wives of Jawans should note in the application that they are wives of Jawans. Such candidates should obtain proper certificates from the Officer commanding stating the name, Military rank and Military address of their husbands and produce the same as and when required by the Commission (G.O.(MS) No. 509/64/Edn. Dated 19.9.1964, G.O.(MS) No. 614/65/Edn. Dated 09.11.65 and G.O.(MS) No.243/ 66/Edn. Dated 27.5.66)
- ii) First Class Scouts and Guides will be given preference in the matter of appointment as Teachers (G.O.(MS) No.122/75/G.Edn. dated 27.05.1975 and GO(MS) No. 50/70/PD dated 12/02/1970)

Note:- The candidates who claim concessions by virtue of any of the above reason shall select “Are you eligible for age relaxation” as “yes” on the online application and give details in the space following. Otherwise the applications are liable to be rejected presuming that they are over aged candidates. Upper age limit after allowing the relaxation as per rule shall not exceed 50 years of age. (See para 2 of General Conditions)

9. Mode of submitting applications:

The applications with photo uploaded shall be submitted online only on the website of the Kerala Public Service Commission viz. www.keralapsc.org. No application fee is required. The candidates applying on-line shall keep the print out (Receipt) of their applications and the barcode number shall be quoted in all further enquiries/correspondence. Documents to prove qualifications, age and community etc have to be produced as and when called for. Applications which are submitted not in accordance with the instructions given in the website will be summarily rejected.

10. Last date for receipt of applications : 16/11/ 2011 Wednesday upto 2 midnight

11. Address to which applications are to be submitted : www.keralapsc.org.

12. If a Written Test/OMR Test is conducted as a part of the selection, Hall ticket of eligible candidates will be made available in the website of Kerala Public Service Commission candidates are instructed to download their Hall Ticket as per the instructions in the website.

13. At the time of examination, Physical Efficiency test, Practical test, interview etc, candidates shall produce their Photo affixed ID proof in original and self attested photocopy (Voters Identity Card, Driving licence, Passport, Identity cards issued by Social Welfare Department, Government of Kerala to physically Handicapped candidates, Photo affixed Pass books issued by Nationalised Banks, PAN card, Identity card issued to Govt. employees by the concerned Departments) along with Hall Ticket.
